Assessment Criteria

The contributions of the individuals and companies submitted in the applications will be assessed on three key criteria: Impact; Implementation; and Innovation.

(1) Impact

Impact of the programs highlighted in the applications will be assessed. Details on the progress made against key project metrics may include, but are not limited to:

- Quantitative results depicting the transformation journey, e.g., increase in sales/revenue, and improvement in staff/customer satisfaction
- Qualitative assessment of the impact of transformation, e.g., staff and client testimonials, and survey feedback highlighting project impact

(2) Implementation

Applications will be assessed on the effectiveness of program and product delivery and should therefore include a concise overview of the implantation plan and metrics. This may include, but is not limited to:

- Implementation process, including timelines, resourcing, and key performance indicators
- Demonstration of efficient program delivery/product development showcasing organizational agility

(3) Innovation

Programs and initiatives in the application will be assessed for their innovative approach and should include details on how the individual and/or company worked towards creating a novel product or program. Some examples include, but are not limited to:

- Developing a new staff or community program to implement a positive work culture and boost employee morale
- Designing a new product that is unique and caters to the evolving needs of the market
- Improving internal processes and operations, for instance through the adoption of new digital tools
